  - ( ) 2. Two payments due August 1 and December 1, 2012 (1% discount) \$2400.75/payment
  - ( ) 3. Military Allotment (Documentation for this option is required)
  - ( ) 4. (10) Equal payments of \$485 beginning August 1, 2012 and ending May 1, 2013\*
- \* A late fee of \$15 will be charged for payments made after the 10<sup>th</sup> of each month.**

### Contractual Terms and Conditions

1. Registration fees received after April 27, 2012 will include an additional \$100. I also understand that the registration fee is non-refundable and must accompany the signed contract.
2. I understand that the registration fee cannot be accepted if the account for the academic year 2011-2012 is in arrears. In such case, any registration fee received will be applied to the balance due to the school for the academic year 2011-2012.
3. **I UNDERSTAND THAT UNLESS WRITTEN NOTICE WITHDRAWING THE APPLICATION IS SENT TO THE PRINCIPAL BY CERTIFIED MAIL NO LATER THAN JULY 1, 2012, THAT MY OBLIGATION TO PAY ALL FEES FOR THE FULL ACADEMIC YEAR 2012-2013 IS UNCONDITIONAL AND THAT NO PORTION OF SUCH FEES SO PAID OR OUTSTANDING WILL BE REFUNDED OR CANCELLED, NOT WITHSTANDING THE SUBSEQUENT ABSENCE, WITHDRAWAL, OR DISMISSAL FROM THE SCHOOL.**
4. I understand that in signing the Tuition Contract for the academic year 2012-2013, I am agreeing to accept the policies, rules and regulations of St. Francis Xavier High School. **Furthermore, I AGREE TO THE POLICY OF THE SCHOOL THAT NO STUDENT WILL BE PERMITTED TO RECEIVE REPORT CARDS, NOR WILL TRANSCRIPTS BE RELEASED, UNLESS ALL FINANCIAL OBLIGATIONS ARE PAID IN FULL.**
5. I understand that if an attorney is retained to collect amounts due under this contract, that I agree that South Carolina law will apply and that I am responsible for all reasonable costs of collection including, but not limited to, attorneys and accountants fees, court costs, and other collection fees.

In addition to the tuition, volunteer work by the family of the student is necessary for the building of community and the financial success of St. Francis Xavier High School. **The expectation is that each family will contribute twenty (20) hours per year. If you are unable to fulfill your twenty service hours, you may buy out for \$10 per hour due by the end of May. A bill will be mailed by the end of April.**
